

CONSENT TO THE PROCESSING OF PERSONAL DATA

under Art. 7 of the Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC
(hereinafter referred to as the “**GDPR**“)

FutureNow is part of the HB Reavis Group, which consists of all entities consolidated under the group holding HB Reavis Holding S.A. with its headquarters in Luxembourg or entities related to it (hereinafter referred to as the “HB Reavis Group“) due to which the reference to HB Reavis Group may be found in the Consent,

free and voluntary consent to the processing of personal data under the below set conditions

What is our purpose for the processing of your personal data?

Taking the photographs and audio-video recordings and using the photographs (where you can appear) and recordings for the purpose of sharing details of online meetings with attendants who could not attend an online meeting. Furthermore, we may process your personal data by taking the photographs and audio-video recordings, and publishing the photographs (where you can appear) and recordings in our social media profiles, our corporate website and our conference website to use them in our presentation for the purpose and legitimate interests of promotion of our events and services and to help us improve our brand and goodwill.

What kind of personal data do we process?

Name, surname, e-mail, telephone and representation of your own appearance (as part of an audio-visual recording/photograph).

For how long do you grant this consent?

Consent is granted for a period of three years.

By signing the consent you further acknowledge that you can withdraw the consent electronically by sending an e-mail to dataprivacy@hbreavis.com, by clicking on “unsubscribe” in any of our e-mail sent to you or by the written request delivered to our current address: FutureNow s. r. o., Mlynské Nivy 16, 821 09 Bratislava - mestská časť Staré mesto, Slovak Republic. You can withdraw the consent before the lapse of the time you granted it for, i.e. at any time. Withdrawal of the consent is without prejudice to the lawfulness of our processing of your personal data prior to such withdrawal.

What is our legal basis for the processing of your personal data?

We process your personal data on the basis of a consent under Article 6 (1) (a) of GDPR.

With whom do we share your personal data?

We may share your personal data within the companies in HB Reavis Group and their processors (if applicable). We also may be obliged to provide your personal data to public authorities, in particular

courts and law enforcement agencies (police and prosecutors) only to the extent necessary and within the limits of the law.

From whom do we get the personal data?

We get personal data from you.

Do we use automated individual decision-making?

No, we do not use automated individual decision-making.

Do we transfer your personal data to third countries?

Your personal data are processed within the territory of the Slovak Republic and other states of the European Union. Your personal data can be processed by a country outside of European Union if this third country has been confirmed by the European Commission as a country with adequate level of data protection or if other appropriate data protection safeguards exist (for example, binding corporate privacy rules or EU standard data protection clauses).

Other information:

Personal data may also, in justified cases, be subject to use (processing) for the purpose of dealing with legal matters, including the performance of public authority obligations and monitoring for possible legal protection. Personal data may also be archived for a given public interest, as well as for scientific, historical or statistical research.

What are your rights?

Your rights as a data subject are stated below. Please note that the exact conditions to exercise these rights are set out in detail in Chapter III of GDPR, while in a particular circumstance not all rights may be exercised. You have following rights:

- Access to personal data we process about you
- Rectification of incorrect or inaccurate personal data and add incomplete personal data
- Restriction, i.e. blocking of processing of your personal data
- The deletion of personal data in case the purpose absence or unauthorized data processing
- Submission of an objection to the processing of personal data if you believe that our data processing is not justified
- Be excluded from automated decision-making
- Listing of personal data in a structured and machine-readable format or for another controller
- Revocation of consent to the processing of personal data
- To lodge a complaint with the supervisory authority
